ITEMS FOR BOARD REVIEW, DISCUSSION AND POSSIBLE ACTION

Investigation Files

File No. 18-110; Nez (Formerly Boice), Edwin

Edwin Nez was present. Andrew White was present and provided a summary of his investigative report. Mr. White's report included that the respondent was impaired when he was involved in a traffic accident and pled guilty to aggravated assault and endangerment. Mr. White's report also included the respondent's failure to notify the Board pursuant to A.R.S. § 32-3208. Mr. Nez summarized the accident, why he failed to notify the Board timely and his rehabilitation and recovery from alcohol.

After discussion, a motion was made by Victoria Bowmann, seconded by John Ortega and passed unanimously to offer a consent agreement to the therapist to include a 24-month probation. During the probationary period, the therapist would be required to take 24 hours of continuing education ("CE") in the area of ethics with all 24 hours to be in addition to the statutorily required CE, preapproved by the Board and in a classroom setting. The therapist will also continue to participate in an Alcoholics Anonymous program that includes meeting at least once a week, meeting with a sponsor and random, quarterly urinalysis testing. The motion included that if the consent agreement is not accepted within 30 days, from the date offered, to proceed to a formal interview.

Formal Hearing(s)

File No. 18-102; Poole, Monique

Monique Poole was not present. Michael Raine was present and appeared on behalf of the State. Mary DeLaat Williams was present to provide independent legal advice to the Board.

The State briefly presented its case and requested that the Board deem the admissions of the State since the respondent failed to respond to the Complaint and Notice of Hearing.

A motion was made by Victoria Bowmann, seconded by Mlee Clark and passed unanimously to deem the admissions in the Complaint and Notice of Hearing.

A motion was made by Vitoria Bowmann, seconded by John Ortega and passed unanimously to adopt the Findings of Fact and Conclusions of Law as written in the Complaint and Notice of Hearing.

After the State requested that the discipline imposed should be revocation, a motion was made by Victoria Bowmann and seconded by John Ortega to issue a Decision and Order ("Order") revoking the respondent's massage therapy license. The motion passed 4-0 by the following roll call vote:

Mlee Clark – Aye John Ortega – Aye Victoria Bowmann – Aye Earl Duskey – Aye

File No. 18-106; Hall, Steven

Steven Hall was present and appeared on his own behalf. Michael Raine was present and appeared on behalf of the State. The complainant was present. Mary DeLaat Williams was present to provide independent legal advice to the Board.

Both parties presented their cases in chief. The state presented its case and concluded that the Board must now decide whether or not to believe the testimony provided by the complainant while at the same time recalling that the complainant has remained consistent with her testimony from the beginning of filing a complaint until the day's testimony. The massage therapist presented his case and concluded that he did not do or commit any of the acts that the complainant stated. He also stated that he has implemented measures in his practice to prevent individuals implying any wrongdoing.

A motion was made by Mlee Clark, seconded by Victoria Bowmann and passed unanimously to adopt the Findings of Fact as written in the Complaint and Notice of Hearing.

A motion was made by Victoria Bowmann, seconded by Mlee Clark and passed unanimously to adopt the Conclusions of Law as written in the Complaint and Notice of Hearing.

A motion was made by Victoria Bowmann and seconded by Mlee Clark to issue a Decision and Order ("Order") revoking the respondent's massage therapy license. The motion passed 4-0 by the following roll call vote:

Mlee Clark – Aye John Ortega – Aye Victoria Bowmann – Aye Earl Duskey – Aye

The Board took a break from 11:14 a.m. to 11:25 a.m.

File No. 18-107; Jamison, Robert

Robert Jamison was present and appeared along with his attorney Dale Beck Furnish. Michael Raine was present and appeared on behalf of the State. The complainant was present. Mary DeLaat Williams was present to provide independent legal advice to the Board.

Both parties presented their cases in chief. The State presented its case and concluded that the Board must now decide to believe one party's version of facts over the other party's, but acknowledge that the complainant was injured and that the breast area was massaged even if the

breasts were not massage. The massage therapist presented his case and concluded that Mr. Jamison did nothing without the complainant's prior consent and that there was some injury, but that there was no intent to harm.

A motion was made by Victoria Bowmann, seconded by Mlee Clark and passed unanimously to adopt Findings of Fact 1-5, 7, 8, 10, 11 & 12 as written in the Complaint and Notice of Hearing and to modify Findings of Fact 6 & 9 with 6 reading, "Respondent indicated to KA his belief that it was not a lump but rather a muscle spasm" and 9 reading, "During the massage, Respondent placed his hand across her sternum, which he indicated was to stabilize her while working on her neck area".

A motion was made by Victoria Bowmann, seconded by John Ortega and passed unanimously to adopt Conclusions of Law 1-4 & 6 as written in the Complaint and Notice of Hearing and to strike Conclusion of Law number 5.

A motion was made by Victoria Bowmann and seconded by Mlee Clark to issue a Decision and Order ("Order") to include probation for one year. During the probationary period, the therapist would be required to take 16 hours of continuing education ("CE") in the areas of ethics and communications with all 16 hours to be in addition to the statutorily required CE, pre-approved by the Board or its Executive Director and in a classroom setting. The motion included Respondent requesting, in writing, to be released from probation at the end of the one year period and the written request must contain a minimum of two hundred (200) words regarding what he has learned in order to prevent a similar circumstance in the future. The motion passed 4-0 by the following roll call vote:

Mlee Clark – Aye John Ortega – Aye Victoria Bowmann – Aye Earl Duskey – Aye

Mary "Tee" Wills, Garnet Adair and Gregory Y. Harris were present on behalf of the American Massage Therapy Association, Arizona Chapter to provide an update regarding the current legislative session and its impact on the Arizona State Board of Massage Therapy.

ITEMS FOR BOARD REVIEW, DISCUSSION AND POSSIBLE ACTION

Investigation Files

File No. 18-111; Bolton, Michael

Michael Bolton was present. Andrew White was present and provided a summary of his investigative report. Mr. White's report included that the respondent was arrested on January 8, 2016 and again on November 11, 2016 for multiple infractions, including domestic violence, assault, abusive language to provoke and driving under the influence. Mr. White's report also included the respondent's failure to notify the Board pursuant to A.R.S. § 32-3208. Mr. Bolton

read a prepared statement into the record regarding his two arrests and that he takes responsibility for his actions. He stated that he admitted to being an alcoholic and is going through many things to rehabilitate and walk in recovery from alcohol.

After discussion, a motion was made by Victoria Bowmann and seconded by Mlee Clark to offer a consent agreement to the therapist to include a one year probation. During the probationary period, the therapist would be required to continue with his rehabilitative treatment within the Alcoholics Anonymous. The motion included that if the consent agreement is not accepted within 30 days, from the date offered, to proceed to a formal interview. The motion passed 4-0 by the following roll call vote:

Mlee Clark – Aye John Ortega – Aye Victoria Bowmann – Aye Earl Duskey – Aye

File No. 18-112; Tolton, Leslie

Leslie Tolton was present. Andrew White was present and provided a summary of his investigative report. Mr. White's report included the complainant's allegations that Mr. Tolton performed a breast massage without prior consent. The complainant was present telephonically and she described her experience as humiliating. She also stated that she filed a report with his employer and provided her testimony to local police for their report. Mr. Tolton explained the technique he used and why he massage both the front and back of her torso, but stated that he moved the complainant's breasts with the back of his hand to reach the side of her torso.

After discussion, a motion was made by Earl Duskey, seconded by Victoria Bowmann and passed unanimously to file a Complaint and Notice of Hearing.

File No. 18-123; Tolton, Leslie

Leslie Tolton was present. Andrew White was present and provided a summary of his investigative report. Mr. White's report included the complainant's allegations that Mr. Tolton performed a massage that included the complainant's breasts, vagina and pelvic region. The report also included verbal, sexual advances that the complainant said was shocking and put her in a vulnerable position where she became motionless and voiceless. The complainant was not present. Mr. Tolton summarized his interaction with the complainant. Mr. Tolton stated that the complainant stated that she is not that modest and does not have a problem being naked. Mr. Tolton stated he did not respond to her statement. He stated he did massage the complainant's gluts and did not go anywhere near her vagina.

After discussion, a motion was made by John Ortega, seconded by Mlee Clark and passed unanimously to file a Complaint and Notice of Hearing.

File No. 18-113; Stewart, Erika

Erika Stewart was not present. Michael Raine was present and provided information regarding the Board's statutes and rules when they have a conviction of prostitution.

A motion was made by Victoria Bowmann, seconded by Earl Duskey and passed unanimously to offer a Consent Agreement for the surrender of the respondent's massage therapy license and if not accepted within 30 days from the date offered to proceed to file a Complaint and Notice of Hearing to revoke the respondent's massage therapy license.

Review Investigation File(s) and Proposed Settlement Offer(s)

File No. 17-109; Vickers, Harrison

Michael Raine provided a summary of the matter and an update regarding the Board's disciplinary process. Mr. Raine stated that it might be more appropriate for the Board to rescind its original motion to conduct a formal hearing in this matter and instead to offer a consent agreement and if not accepted to move the matter to a formal interview. Mr. Raine summarized what a consent agreement could read based on the allegations of a massage that was too much pressure.

A motion was made by Victoria Bowmann, seconded Mlee Clark and passed unanimously to rescind the Board's original motion to file a Complaint and Notice of Hearing and instead offer a consent agreement for six hours of continuing education in the areas of ethics and communication and if not accepted within 30 days of the offer being offered to move the matter to a formal interview.

File No. 18-104; Wang, Zhonghui

Michael Raine provided an update regarding the Board's offer and the respondent's counter offer. Mr. Raine stated that the counter offer includes the same facts as offered in the consent agreement would remain the same, including a breast massage, being performed, without prior written consent. However, the fact that the intent was sexual in nature would be omitted.

A motion was made by Victoria Bowmann and seconded by John Ortega to accept the counter offer. The motion passed 4 - 0 by the following roll call vote:

Mlee Clark – Aye John Ortega – Aye Victoria Bowmann – Aye Earl Duskey – Aye

Board Elections

After a brief discussion, a motion was made by Victoria Bowmann, seconded by Mlee Clark and passed unanimously to elect Earl Duskey as Chair of the Board and Victoria Bowmann as Vicechair of the Board.

EXECUTIVE DIRECTOR'S REPORT

The Board reviewed the budget and agency operations with Ryan P. Edmonson, including adding monthly meetings and cancelling meetings as necessary.

A motion was made by Earl Duskey, seconded by Victoria Bowmann and passed unanimously to accept the meetings as scheduled by staff.

ASSISTANT ATTORNEY'S GENERAL REPORT

Michael Raine provided a summary of the Board's duties as it relates to delegating authority to the Executive Director for purposes of granting initial licenses and renewal licenses.

After discussion, a motion was made by Earl Duskey, seconded by Mlee Clark and passed unanimously to delegate the Board's authority to the Executive Director to grant initial and renewal licenses to massage therapists provided there is no substantive or questionable reason not to grant a license.

COUNCIL ON LICENSURE, ENFORCEMENT & REGULATION ("CLEAR")

After Ryan P. Edmonson provided an overview of the CLEAR conference, a motion was made by Victoria Bowmann, seconded by Earl Duskey and passed unanimously to approve Andrew White's attendance and travel to the CLEAR National Certified Investigator & Inspector Training held in Austin, Texas from April 9, 2018 – April 11, 2018.

FEDERATION OF ASSOCIATIONS OF REGULATORY BOARDS ("FARB")

After Ryan P. Edmonson provided an overview of the FARB conference, a motion was made by Bill Beard, seconded by Earl Duskey and passed unanimously to approve the Executive Director's attendance at the 2018 FARB Forum held in Coronado, California from Thursday, January 25, 2018 – Sunday, January 28, 2018.
