DECISION AND ORDER

RESPONDENT


8 On October 29, 2018, the Arizona State Board of Massage Therapy (“Board”) convened to
9 hold an Administrative Hearing in the above referenced matter. Mario Anthony Cisneros
10 (“Respondent”) did not appear and was not represented by legal counsel. Assistant Attorney
11 General Michael Raine was present and represented the State. Assistant Attorney General, Marc
12 H. Harris, of the Licensing and Enforcement Section of the Attorney General’s Office, appeared
13 in person to provide independent legal advice to the Board. At issue was the State’s Motion to
14 Deem Allegations Admitted regarding the Complaint and Notice of Hearing in this matter and the
15 imposition of the appropriate disciplinary action(s) pursuant to A.R.S. § 32-128(F). The Board,
16 after considering the State’s Motion, granted the Motion to Deem the Allegations Admitted and
17 issued the following Findings of Fact, Conclusions of Law and Order (“Decision and Order”):

18 **FINDINGS OF FACT**

- 19 1. On October 16, 2017, Respondent provided massage therapy services to client DB
20 at Massage Envy in Chandler, Arizona.
- 21 2. During the massage, Respondent massaged oil onto DB’s perineum, touched DB’s
22 bare penis with his bare hand, and asked DB if he could rub oil on DB’s penis.
- 23 3. Respondent admitted to Massage Envy management that his massage exceeded or
24 departed from the scope of massage therapy services and into what Respondent labeled as
25 “holistic” healing.


