**FINDINGS OF FACT,
CONCLUSIONS OF LAW, AND
ORDER**

9 Pursuant to Complaint and Notice of Hearing, Case number 16-111 (Notice) this matter
10 came before the Arizona Board of Massage Therapy (Board) on September 26, 2016.

11 Victoria Bowman, Chairperson, presided at the meeting with Board members Earle
12 Duskey and Diane Pruetz in attendance.

13 The State was represented by the Office of the Attorney General, Elizabeth Campbell,
14 Licensing and Enforcement Section. Bridget Harrington, Assistant Attorney General, was
15 present and available to provide independent legal advice to the Board. Gabriel Houseal
16 was present and was not represented by an attorney.

17 The Board, after considering the testimony and evidence presented, hereby issues the
18 following Findings of Fact, Conclusions of Law, and Order.

PARTIES AND JURISDICTION

19 1. The Board is the duly constituted authority for licensing and regulating the
20 practice of massage therapy in the State of Arizona.

21 2. Respondent holds license number MT-19171, which allows him to practice
22 as a massage therapist in the State of Arizona.

23 3. Under A.R.S. § 32-4201, *et seq.*, the Board possess jurisdiction over the
24 subject matter and over Respondent as a licensee of the Board.

1 decision has the effect of prohibiting the parties from seeking judicial review of the
2 Board's decision.
