10 At its public meeting on July 20, 2015, the Arizona Board of Massage Therapy (Board)
11 voted to require Respondent to obtain non-disciplinary continuing education in ethics.

12 **ORDER**

13 IT IS HEREBY ORDERED that before October 26, 2015, Respondent shall complete a
14 minimum of 8 classroom hours of Board staff pre-approved continuing education in ethics. The
15 continuing education shall be in addition to the hours required for the annual renewal of his
16 massage therapy license. Respondent shall send documentation of completion of the continuing
17 education to the Board office on or before October 6, 2015. Respondent's failure to complete the
18 continuing education will subject him to future disciplinary action by the Board. (A.R.S. § 32-
19 4253 (A)(23).

20 **NOTICE**

21 Respondent is hereby notified of the right to petition for review by filing a petition with
22 the Board's Executive Director within thirty (30) days after service of this Order. A.A.C.
23 R4-15-401(A). The petition must set forth specific and legally sufficient reasons for granting
24 review. A.A.C. § R4-15-401(C). Service of this order is effective five (5) days after mailing. If a
25 petition for review is not filed, the Board's Order becomes effective thirty-five (35) days after it
26 is mailed to Respondent.

27 Respondent is further notified that the filing of a petition for review is required for review is
28 required to preserve any rights of appeal to the Superior Court.
