NON-DISCIPLINARY ORDER FOR  
CONTINUING EDUCATION (Corrected)

9 At its public meeting on July 20, 2015, the Arizona Board of Massage Therapy (Board)  
10 voted to require Respondent to obtain non-disciplinary continuing education because of its  
11 concerns that Respondent, who provides different types of modalities of treatment, is not always  
12 clear about what modality or treatment is being provided.

13 ORDER

14 IT IS HEREBY ORDERED that before October 26, 2015, Respondent shall complete a  
15 minimum of 8 classroom hours of Board staff pre-approved continuing education in business and  
16 ethics. The continuing education shall be in addition to the hours required for the annual renewal  
17 of her massage therapy license. Respondent shall send documentation of completion of the  
18 continuing education to the Board office on or before October 26, 2015. Respondent's failure to  
19 complete the continuing education will subject her to future disciplinary action by the Board.  
20 (A.R.S. § 32-4253 (A)(23).


21 NOTICE

22 Respondent is hereby notified of the right to petition for review by filing a petition with  
23 the Board's Executive Director within thirty (30) days after service of this Order. A.A.C.  
24 R4-15-401(A). The petition must set forth specific and legally sufficient reasons for granting  
25 review. A.A.C. § R4-15-401(C). Service of this order is effective five (5) days after mailing. If a  
26 petition for review is not filed, the Board's Order becomes effective thirty-five (35) days after it  
27 is mailed to Respondent.

28 Respondent is further notified that the filing of a petition for review is required for review is  
29 required to preserve any rights of appeal to the Superior Court.
