10 In the State of Arizona.

11 At its public meeting on April 26, 2010, the Arizona Board of Massage Therapy
12 (“Board”) considered case number 09-103 concerning Jaren Winterhoff (“Respondent”),
13 license number MT-10359. Based upon its review of the case, the Board determined
14 that Respondent’s massage technique could have been improved and that he could have
15 communicated more clearly with the client. As a result, the Board voted under A.R.S. §
16 32-4254(C)(3) to require Respondent to obtain a total of 20 hours of non-disciplinary
17 continuing education.

18 **ORDER**

19 IT IS HEREBY ORDERED that Respondent shall, within 60 days after the
20 effective date of this Order, obtain a total of 6 hours of Board Staff pre-approved
21 continuing education in ethics and 14 hours of Board Staff pre-approved continuing
22 education in trigger point therapy. The continuing education hours shall be in addition
23 to the hours required for the renewal of Respondent’s massage therapist license under
24 A.R.S. § 32-4225. Respondent’s failure to complete the continuing education will
25 subject him to future disciplinary action by the Board. A.R.S. § 32-4253(A)(23).


1 informed the Board that he had not yet been able to find an acceptable trigger point

3 **Consequently, as of the effective date of this Amendment, the Order in Case**
4 **No. 09-103 is amended to read as follows:**

5 IT IS HEREBY ORDERED that on or before **November 21, 2010**, Mr.
6 Winterhoff shall complete 14 hours of Board staff pre-approved continuing education
7 in trigger point therapy. The continuing education hours shall be in addition to the
8 hours required for the renewal of Mr. Winterhoff's massage therapist license under
9 A.R.S. § 32-4225. Mr. Winterhoff's failure to complete the required continuing
10 education by November 21, 2010, will subject him to future disciplinary action by the
11 Board. A.R.S. § 32-4253(A)(23).

12 IT IS FURTHER ORDERED that Mr. Winterhoff shall personally appear at
13 the Board's November 22, 2010, Board meeting to report to the Board whether he has
14 completed the continuing education required by this Amended Order.


