Ms. Retting was present to address the Board regarding continuing education requirements.

MOTION: Ms. Green moved to approve the consent agenda as listed. Ms. Boyer seconded the motion.

VOTE: The motion passed 3-0

- 4. Discussion and Consideration of Application(s) for Licensure Regulatory Matters
  - Α. Parameters for consent agenda items. R415-101 Definitions, 8.D Good Moral Character

Dr. Runbeck summarized the parameters for the consent agenda on the definitions on "Good Moral Character" for the Board. The Board is bound by its statutes and the five year limitation for Good Moral Character. Does the Board wish to pursue statute changes so the Board will have more latitude with regards to application requirements? Ms. Concordia asked that the Board review the statute changes and put on as a future agenda item to review more thoroughly.

#### B. Board Review

1. Jennifer Crall

Ms. Crall was present to answer questions from the Board regarding her application for licensure.

Ms. Doyle summarized this application for the Board. Ms. Crall answered yes to question #29 on her application. Ms. Crall has a Consent Agreement with the City of Phoenix for her establishment license for employing unlicensed massage therapist.

MOTION: Ms. Green moved to approve Ms. Crall application for licensure with a Letter of Concern regarding ethical

practice and to be above reproach and no gray areas. Ms. Boyer seconded the motion.

2. Betty Hawley

Ms. Hawley was present to answer questions from the Board regarding her application for licensure.

Ms. Doyle summarized this application for the Board. Ms. Hawley background check shows she was arrested on 2/16/04 and charged with Assault-Touched to injure. She was found guilty.

Ms. Lee assistant attorney general asked if Ms. Hawley had satisfied her probation.

Ms. Boyer asked to have this matter tabled by the Board until Ms. Hawley could provide documentation regarding her probation.

Ms. Hawley acquired documentation from the Phoenix Court and she will be on probation until April 05. The Board tabled this matter until Ms. Hawley obtains documentation releasing her from probation.

3. Rebecca Kuzyk

Ms. Kuzyk was present to answer questions from the Board regarding her application for licensure.

Ms. Doyle summarized this application for the Board. Ms. Kuzyk's background check shows she was arrested on 6/1/2003 and charged with a Felony in Guymon, Oklahoma, she also answered yes to questions #20 and 23 on her application.

**MOTION:** Ms. Boyer moved to deny Ms. Kuzyk's application for licensure. Ms. Green seconded the motion.

4. Christopher Nixon

Mr. Nixon was not present at the Board meeting.

Ms. Doyle summarized this application for the Board. Mr. Nixon answered all but one of the questions on his application however his background check came back with a conviction on 11/22/00 guilty and 3 years probation with 6 months in jail.

The Board tabled this matter to obtain further information from Mr. Nixon regarding his probation status.

5. Anna Prassa

Ms. Prassa was present to answer questions from the Board regarding her application for licensure.

Ms. Doyle summarized this application for the Board. Ms. Prassa's background check shows she was arrested on 11/18/200 and charged with Assault-touch to injure. She was placed on probation for one year.

**MOTION:** Ms. Green moved to approve Ms. Prassa's application for licensure. Ms. Boyer seconded the motion.

**VOTE:** The motion passed 3-0

6. Jian Xia Zhang

Ms. Zhang was not present at the Board meeting.

Ms. Green recused herself from this review of Ms. Zhang's application.

The Board tabled Ms. Zhang application for licensure for lack of a quorum.

7. JoAnn Ruszel-Margeson

Ms. Ruszel-Margeson was present to answer question from the board regarding her application for licensure.

Ms. Doyle summarized this application for licensure for the Board. Ms. Ruszel-Margeson submitted an official transcript to the Board showing an AS Degree in Physical Therapy instead of Massage Therapy.

motion.

8. Diane Peterson

Ms. Petersen was present to answer questions by the Board regarding her application for licensure.

Ms. Concordia asked Ms. Petersen why she did not want to take and pass the National Certification Board exam which would be the only way Ms. Petersen could be licensed in Arizona.

The reciprocity and provisional requirements were not meet by Ms. Petersen information sent with her application.

Ms. Petersen answered the Board; with she feels she has already completed thru her extensive number of hours and studies over a three year period of time what is necessary for licensure and because she held city licenses in Aurora and Denver Colorado this should qualified her for an Arizona license.

Ms. Concordia went over the Board statutes and how an applicant can be licensed in Arizona. Ms. Petersen could obtain a license in the State of Arizona if she would take and pass the National Certification Board exam then she could come in under the regular application.

Ms. Petersen then stated that she was applying under the Reciprocity application. She is coming from the state of Colorado but Colorado is a non licensing state.

Ms. Concordia Tabled this matter until the January 31, 2005 Telephone conference to review additional information in Ms. Petersen's file.

9. Serina Hernandez

Ms. Hernandez was unable to attend this board meeting.

Ms. Concordia moved to Table Ms. Hernandez's application to obtain additional information regarding the dates of her arrest. The board will need information regarding the charge and what she was convicted of and if she is still on probation.

Ms. Boyer seconded the motion.
